ABOUT SHRI V. R. DESHPANDE MEMORIAL TRUST

Shri V. R. Deshpande Memorial Trust (VRDM Trust), established in 1998, is a memorial initiative dedicated to Shri V. R. Deshpande's legacy, fostering positive change for over two decades, focusing on prime concerned areas like rural development and eradication of social evils, supporting meritorious students of economically deprived class and supporting Indian traditional sports.

In the year 2004 the Trust established various Institutions of its own to reach the target population for actual rural development. Canara Bank Deshpande Rural Self Employment Training Institute (CBD-RSETI) is engaged in Self-Employment Trainings for rural youth and also handling Rural Development activities. Institute is partnered with Canara Bank. The Institute is registered under the Society Act as 'Society' and the VRDM Trust and Canara Bank are the main sponsors to this Society.

With a view to give solid technical foundation to the rural youth, the Trust established a private ITI under the name of Deshpande Private Industrial Training Institute. The Institute offers various technical trades and is affiliated to National Council for Vocational Training - NCVT. The Institute has partnered with various National and Multi National corporates for reaching optimal standards in imparting skills. The institute also offers training to various corporates in upgrading the skills of their workforce.

To bring the rural schooling at par with the urbanites, the Trust started Vimal V. Deshpande School of Excellence with State-of-the-art facility. The school is affiliated to CBSE, New Delhi and imparts comparable holistic education and new age skills to the students.

Besides these activities, the Trust arranges National Level Wrestling Competition at Haliyal. It also awards scholarships to meritorious students. The Trust also helps the rural population to take benefit of all Governmental Schemes.

The Trust has continuous Health and Hygiene Programs for rural population. The Trust is also active in environmental consciousness and conservation of natural resources through the programme "Jal Sanjeevan".

FOUNDERS' DAY

1st July is the Birthday of Late Shri V. R. Deshpande, Every year, Trust Celebrates Founders' Day in his memory. To make this day more meaningful, series of activities will be carried out, like Scholarship Distribution to meritorious students in the District, Free Health Check-up Camps, Organizing Voluntary Blood Donation Camps & Free Eye Checkup Camps etc.

HEALTH CAMPS:

On the occasion of Founders' Day, voluntary Blood Donation camps were organised at Haliyal, Joida and Mundgod. 103 blood units were collected in these camps. Cancer Hospital's Blood Bank at Navanagar, Hubli, PG IMA lifeline Blood Bank Sirsi and Blood Bank, Karwar were supported this activity.

In addition to these 3 camps, totally 14 Blood Donation Camps with regular intervals were organised during the year 2022-23 at Haliyal, Joida and Mundgod Taluks and more than 500 blood units were collected. With this, Trust is making efforts in bringing Social Concern, Voluntary Involvement and Self Motivation among the youth.

CARDIOLOGY @ DOOR STEPS (CAD)

Inadequate ECG (electrocardiography) facilities and delayed diagnosis is leading to deaths in a majority of heart attack cases in rural areas. Cardiology @ Door steps (CAD) Project supports in preventing massive heart attack in rural places. Cardiology @ Door steps (CAD) Project has been launched on 14th July, 2022.

Our Trust with the help of Philanthropic support, has provided 15 ECG Machines to Taluka Hospitals at Dandeli and Joida including 11 PHCs and 2 Sub Centres in Haliyal, Dandeli and Joida regions.

Cardiology at Doorsteps (CAD) has been at the forefront of tele cardiology segment especially in rural India. Dr Padmanabh Kamath Founder of this CAD Project. CAD Project created the ECG awareness program and installation in 23 Districts and in 325 Primarily Health Care Centers and local Govt. Hospitals and uniting 2500 + doctors in Pan India Project. Distribution of ECG Machines helps people from rural area in getting quick access to health care at Primary Health Centres. It helps the Primary Health Care Centre doctors to find the exact reason and early detection of heart diseases.
